

So Delicious Dairy Free 'Pint of No Return' Sweepstakes ("Sweepstakes")  
OFFICIAL RULES ("Official Rules")

**NO PURCHASE OR PAYMENT OF ANY KIND NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING. INTERNET ACCESS REQUIRED. VOID WHERE PROHIBITED BY LAW. BY PARTICIPATING IN THIS SWEEPSTAKES, YOU AGREE TO BE BOUND BY THESE OFFICIAL RULES AND THE DECISIONS OF THE SPONSOR, WHICH SHALL BE FINAL AND BINDING IN ALL RESPECTS. **ELIGIBILITY:** Open only to legal U.S. residents residing in one (1) of the fifty (50) United States and the District of Columbia, who are at least eighteen (18) years of age or older (at least nineteen (19) in Alabama and Nebraska) with a valid US driver's license or government issued photo ID at the time of entry. The following individuals are not eligible to participate: officers, directors, employees, contractors, representatives and agents of Danone US, LLC (the "Sponsor"), Southern Made Services, LLC (the "Administrator"), C3 Presents, LLC, Lollapalooza, LLC and Caring & Daring, LLC (the "Event Entities"), and each of their respective parents, subsidiaries and affiliates, and if applicable, their advertising or promotion agencies (including Inspira Marketing), distributors, Web design, advertising, fulfillment, program prize suppliers, and promotion agencies involved in the administration, development, fulfillment, and execution of this sweepstakes (collectively, the "Sweepstakes Parties"), and members of their immediate families (spouse, parent, child, sibling, grandparent, and spouse or "step" of each) and those living in the same household of each such person (those persons whether related or not who live in the same residence for at least three [3] months during the twelve-month period preceding the start date of the Sweepstakes).

Entrant must have a public profile on TikTok used to enter in order to be contacted by Sponsor if he/she is selected as a potential winner. To receive one (1) Bonus Entry Entrant will share their quiz results using hashtag #SDDFPintofNoReturnSweeps.
- 4) **Instagram Bonus Entry:** Visit the Website and click the "Follow" button. Entrant will then be instructed to create or log in to your Instagram Account. Entrant must follow @so\_delicious on Instagram and have a public profile on the Instagram Account used to enter in order to be contacted by Sponsor if he/she is selected as a potential winner. Entrant must remain a follower of So Delicious Dairy-Free on Instagram through July 31, 2025 to be eligible.
- 5) **TikTok Bonus Entry:** Visit the Website and click the "Follow" button. Entrant will then be instructed to create or log in to your TikTok Account. To follow @sodeliciousdairyfree on TikTok, visit <https://www.tiktok.com/@sodeliciousdairyfree> and click on the "Follow" button to receive one (1) Bonus Entry. Entrant must follow of @sodeliciousdairyfree on TikTok and have a public profile on the TikTok Account used to enter in order to be contacted by Sponsor if he/she is

selected as a potential winner. Entrant must remain a follower of So Delicious Dairy-Free on TikTok through July 31, 2025 to be eligible.

In the event that a dispute regarding the identity of the individual who submitted an Entry cannot be resolved to Sponsor's satisfaction, the affected Entry will be deemed ineligible. Those who do not follow all of the instructions, provide the required information in their entry form, or abide by these Official Rules or other instructions of Sponsor may be disqualified. Standard data rates may apply if the Website is accessed via a mobile device, and Entrants are solely responsible for any such charges. Proof of *submission is not proof* of receipt by Sponsor. Entries submitted by Entrants who do not meet the eligibility requirements (including all requirements with respect to age and residence) are void.

**SWEEPSTAKES DRAWINGS ("DRAWINGS") AND ODDS OF WINNING:** Winners will be randomly selected under the discretion of the Administrator. Sweepstakes Drawings will be conducted by the Administrator, from among all eligible Sweepstakes Entries received during the Sweepstakes Period. Odds of winning depend on the number of eligible Sweepstakes Entries received for the Drawing. The Sponsor's decisions shall be final and binding on all matters relating to the Sweepstakes. Winner will be selected and notified on or around June 30, 2025. Winners will be contacted via email or phone.

**PRIZE (the "Prize") AND APPROXIMATE RETAIL VALUE ("ARV"):**

Grand Prize: One (1) Sweepstakes Prize winner ("Sweepstakes Winner") will be awarded in a random drawing from among eligible Entries received during the Sweepstakes Period. The Sweepstakes Winner will receive a trip for Sweepstakes Winner and one guest ("Guest") (who must be 18 or older unless from Alabama or Nebraska, then 19 or older) to Chicago, IL for the 2025 Lollapalooza Music Festival scheduled to take place on August 1, 2025 - August 4, 2025 (the "Event"). Prize includes two (2) 4-day VIP tickets to the Event, all details determined by Sponsor in its sole discretion; round trip, coach-class air transportation for Sweepstakes Winner and one (1) Guest via a Sponsor-selected air carrier(s) from a major commercial airport selected by Sponsor in its sole and absolute discretion to a major airport near the destination city; and five (5) nights' accommodations (double occupancy) in a 4-star hotel. The ARV of all 1<sup>st</sup> Prizes is \$1,000.**

**The ARV of all Prizes in this Sweepstakes is \$7,500.**

**PRIZE TERMS AND CONDITIONS:** All Event tickets are subject to certain terms and conditions. If a selected Sweepstakes Winner is unable to accept a Prize in its entirety for any reason, the Prize (or that portion of the Prize) may be forfeited. All Entries and potential Sweepstakes Winner is subject to verification by the Sponsor and the Administrator whose decisions are final and binding. the event that the Prize has been forfeited for any reason stated in these Official Rules. Shipping is included. 1<sup>st</sup> Prizes may take 8-10 weeks to arrive. Sponsor makes no representations or warranties of any kind concerning the appearance, safety, or performance of any Prize. Sweepstakes Winners shall bear all risk of loss or damage to 1<sup>st</sup> Prize after it has been delivered.

**SWEEPSTAKES WINNER NOTIFICATION AND PRIZE CLAIM:** Sweepstakes Winner is subject to verification. The potential Sweepstakes Winner will be notified via email using the email address supplied during registration. The potential Sweepstakes Winner will have three (3) business days to respond via return email with their acceptance of the Prize. Upon the acceptance, the potential Sweepstakes Winner will be sent Winner documents via a DocuSign email and will be required to verify his/her/their eligibility by completing, signing, and returning an Affidavit of Eligibility/Liability Release, and, where lawful, a Publicity Release, and a completed and signed Federal Form W-9, by email by the date indicated on the documents or Prize may be forfeited and an alternate Sweepstakes Winner may be contacted. Failure to provide all required information, and a signature on the documents will result in forfeiture of the Sweepstakes Winner's right to claim a Prize and may be awarded to an alternate Sweepstakes Winner.

In Sponsor's sole discretion, if any portion of the Sweepstakes is not capable of running as planned for any reason, or the integrity and/or feasibility of the Sweepstakes is severely undermined by any event beyond the control of Sponsor, including but not limited to fire, flood, health pandemic or epidemic, earthquake, explosion, extreme weather conditions, interruptions in air travel, labor dispute or strike, act of God or public enemy, satellite or equipment failure, riot or civil disturbance, war (declared or undeclared), terrorist threat or activity, or any federal, state, or local government law, order, or regulation, order of any court or jurisdiction, infection by

computer virus, unauthorized intervention, technical failures or other cause not reasonably within the control of Sponsor (each a "Force Majeure" event or occurrence), Sponsor shall have the right, in its sole discretion, to abbreviate, modify, suspend, cancel or terminate the Sweepstakes without any further obligation. In the event of cancellation, Sponsor will award the Prize for the Sweepstakes Drawing(s) at issue in random drawing(s) from among all valid and eligible Entries received for the applicable Drawing(s) up to the time of such cancellation, provided a sufficient number of Entries are received. In no event will more than the number of Prize stated in these Official Rules be awarded. In the event that an Entry is confirmed to have been erroneously deleted, lost, or destroyed, the Entrant's sole remedy shall be another Entry into the Sweepstakes.

**BINDING ARBITRATION:** The parties waive all rights to trial in any action or proceeding instituted in connection with these Rules, including, without limitation, the Sweepstakes. The parties each agree to finally settle all disputes only through arbitration; provided, however, the Sponsor shall be entitled to seek injunctive or equitable relief in the state and federal courts in New York, and any other court with jurisdiction over the parties. In arbitration, there is no judge or jury, and review is limited. The arbitrator's decision and award are final and binding, with limited exceptions, and judgment on the award may be entered in any court with jurisdiction. The parties agree that, except as set forth above, any claim, suit, action or proceeding arising out of or relating to this Sweepstakes shall be resolved solely by binding arbitration before a sole arbitrator under the streamlined Arbitration Rules Procedures of JAMS Inc. ("JAMS") or any successor to JAMS. In the event JAMS is unwilling or unable to set a hearing date within fourteen (14) days of the filing of a "Demand for Arbitration", then either party can elect to have the arbitration administered by the American Arbitration Association ("AAA") or any other mutually agreeable arbitration administration service. If an in-person hearing is required, then it will take place in New York. The federal or state law that applies to these Official Rules will also apply during the arbitration. Disputes will be arbitrated only on an individual basis and will not be consolidated with any other proceedings that involve any claims or controversy of another party, including any class actions; provided, however, if for any reason any court or arbitrator holds that this restriction is unconscionable or unenforceable, then the agreement to arbitrate does not apply and the dispute must be brought in a court of competent jurisdiction in New York. Sponsor agrees to pay the administrative and arbitrator's fees in order to conduct the arbitration (but specifically excluding any travel or other costs of Entrant to attend the arbitration hearing). Either party may, notwithstanding this provision, bring qualifying claims in small claims court. This Sweepstakes is offered only in the United States and is governed by the laws of the state of New York,

and all claims must be resolved in the federal or state courts located in Collin or Dallas counties, New York. **THE ARBITRATION OF DISPUTES PURSUANT TO THIS PARAGRAPH SHALL BE IN THE ENTRANT'S INDIVIDUAL CAPACITY, AND NOT AS A PLAINTIFF OR CLASS MEMBER IN ANY PURPORTED CLASS OR REPRESENTATIVE PROCEEDING.
